Foreign Exchange Act, 2006 (Act 723) **Documentation Manual**

With the coming into force of the Foreign Exchange Act, 2006 (Act 723) the Bank of Ghana issued Operational Guidelines under Notice No. BG/ GOV/ SEC/2007/4 dated March 15, 2007. Banks are therefore required to ensure that applications for transfer of funds abroad are adequately supported by the underlying documents as listed below for various types.

Imports

Under Letters of Credit 1.1

- Pro-forma Invoice
- Import Declaration Form
- Pre-shipment Inspection Certificate

1.2 Imports under collection

- Seller's Final Invoice
- Custom Declaration Form or Bill of Entry
- Import Declaration Form
- Inspection Certificate or such other certificate as may be required.

1.3 Importation of Aircraft and Sea Going Vessels

- Documents in addition to those listed in (a) / (b) should include:
 - Air/Sea worthy Certificate Valuation Report

1.4 Imports by Direct Transfer or Payment

- The importer may request his/her bankers to either issue Him/her with a bank draft or directly transfer amounts, up to the equivalent of \$50,000 abroad on his/her behalf.
- The mode of transfer should be at the discretion of the dealer banks.
- As evidence of receipt and clearance of the goods in Ghana, the importer shall submit the Customs Declaration Form (or Bill of Entry) covering the import to his/her bankers not later than three (3) months after the transfer has been effected to qualify for future transfers.

 No importer shall cause transfer of foreign exchange abroad
- for the purpose of importing goods if he or she has not fully accounted for an outstanding transfer.
- No dealer bank shall transfer foreign exchange abroad on behalf of any importer for the purpose of importing goods if the importer has not fully accounted for any outstanding transfer.

1.5 Imports by Cash on Delivery

- Importers may import goods by cash on delivery basis.
- The local representative of the foreign supplier shall deliver the import documents to the importer against payment for the goods
- The local bank must collect and retain the following documents on the transaction for record purposes.
 - Seller's final invoice
 - Bill of Lading or Airway Bill
 - Customs Declaration Form (or Bill of Entry).

- Manifest
- Auditors Certification of sales and related expenses.
- Tax Clearance Certificate

*Applicant should have enough balance in the bank account to cover the transfer request of the period. (No overdrafts).

Foreign Earnings due Foreign Shipping Lines/Other Freighters 3

Invoice or Bill (claim by carrier)

*Applicant should have adequate balance in account to cover transfer.

Repatriation of Expatriate Personnel's Emoluments

- Resident and Work Permit
- Appointment or Contract Letter
- Income Tax Clearance Certificate (current).

5 **Principal and interest on Foreign Credits**

- Copy of Loan Agreement
- Evidence of inflow of funds/or delivery of loan funded equipment/item into Ghana.
